- 17.6 The fax referred to in Paragraph 17.1 contains a total of two (2) separate and distinct violations of 47 USC § 227, and an additional one (1) violation of the Colorado Consumer Protection Act, for a total of three (3) statutory violations

XVIII. FACTUAL ALLEGATIONS AND CLAIMS FOR RELIEF AS TO DEFENDANTS SKYLINE FEDERAL MORTGAGE CORPORATION, AND TRAVIS O. WILLIAMS, INDIVIDUALLY

- 18.1 On or about January 17, 2002, Guys and Dolls, Inc. received one unsolicited facsimile advertisement ("fax") sent on behalf of Skyline Federal Mortgage ("Skyline"). A copy of the subject fax is attached hereto and incorporated by reference as Exhibit #17.
- 18.2 The fax referred to in Paragraph 18.1 above was sent without Guys and Doll's prior express permission or invitation, and therefore, constitutes a distinct violation of 47 USC § 227(b)(1)(C).
- 18.3 The fax referred to in Paragraph 18.1 above was sent without having clearly marked in a margin at the top or bottom of each transmitted page of the message or on the first page of the transmission, the date and time it was sent, an identification of the business, other entity or individual sending the message, and the telephone number of the sending machine or of such business, other entity or individual. This constitutes an additional violation of the statutory prohibitions of 47 USC § 227.
- 18.4 The fax referred to in Paragraph 18.1 above failed to include therein, a proper toll-free telephone number for removal as required under CRS Section 6-1-702(1)(b)(I).

- 18.5 As listed with the Colorado Secretary of State, the President and Registered Agent of Skyline is Travis O. Williams. Upon information and belief, Mr. Travis O. Williams is a shareholder. Mr. Williams has conducted business with inadequate or thin capitalization for the business in which he is or has been engaged and/or has used the business for an illegal or fraudulent purpose, (i.e., to engage in the practice of transmitting large numbers of unsolicited fax advertisements) in violation of the law. Accordingly, the corporate veil should be pierced or disregarded, and Mr. Williams held liable for all damages under any and all counts of the Complaint attributable to Skyline. Alternatively, Mr. Williams is the person in control of Skyline's activities, Skyline's advertising policies, and Skyline's facsimile transmittal policies. Therefore, Mr. Williams is personally liable for all damages under any and all counts of the Complaint attributable to Skyline Federal Mortgage Corporation.
- 18.6 The fax referred to in Paragraph 18.1 contains a total of two (2) separate and distinct violations of 47 USC § 227, and an additional one (1) violation of CRS Section 6-1-702(1)(b)(I) for a total of three (3) statutory violations.

XIX. FACTUAL ALLEGATIONS AND CLAIMS FOR RELIEF AS TO DEFENDANTS STEVEN S. HOPKINS, D.D.S., P.C., AND INDIVIDUALLY

- 19.1 On or about June 5, 2002, Lehrer Metal Products Co., Inc., ("Lehrer") received one unsolicited facsimile advertisement ("fax") sent on behalf of Steven S. Hopkins, D.D.S., P.C. ("Hopkins"). A copy of the subject fax is attached hereto and incorporated by reference as Exhibit #18.

- 19.2 The fax referred to in Paragraph 19.1 above was sent without Lehrer's prior express permission or invitation, and therefore, constitutes a distinct violation of 47 USC § 227(b)(1)(C).
- 19.3 The fax referred to in Paragraph 19.1 above was sent without having clearly marked in a margin at the top or bottom of each transmitted page of the message or on the first page of the transmission, the date and time it was sent, an identification of the business, other entity or individual sending the message, and the telephone number of the sending machine or of such business, other entity or individual. This constitutes an additional violation of the statutory prohibitions of 47 USC § 227.
- 19.4 The fax referred to in Paragraph 19.1 above failed to include therein, a proper toll-free telephone number for removal as required under CRS Section 6-1-702(1)(b)(I).
- 19.5 As listed with the Colorado Secretary of State, the Registered Agent of Hopkins is Steven S. Hopkins. Upon information and belief, Mr. Steven S. Hopkins is a shareholder. Mr. Hopkins has conducted business with inadequate or thin capitalization for the business in which he is or has been engaged and/or has used the business for an illegal or fraudulent purpose, (i.e., to engage in the practice of transmitting large numbers of unsolicited fax advertisements) in violation of the law. Accordingly, the corporate veil should be pierced or disregarded, and Mr. Hopkins held liable for all damages under any and all counts of the Complaint attributable to Hopkins. Alternatively, Mr. Hopkins is the person in control of Hopkins' activities, Hopkins' advertising policies, and Hopkins' facsimile transmittal policies. Therefore, Mr. Hopkins is personally liable for all damages under any and all counts of the Complaint attributable to of Steven S. Hopkins, D.D.S., P.C.

19.6 The fax referred to in Paragraph 19.1 contains a total of two (2) separate and distinct violations of 47 USC § 227, and an additional one (1) violation of CRS Section 6-1-702(1)(b)(I) for a total of three (3) statutory violations.

XX. CLAIMS AS TO ALL DEFENDANTS

A. Negligence Per Se and Negligence

- 20.1 The allegations of paragraphs 4.1 through 19.6 above are incorporated herein by reference.
- 20.2 At the time of the respective occurrences in question in this case, the TCPA was in effect.
- 20.3 Violation of the statute (TCPA) by the defendants constitutes negligence as to each respective defendant. The conduct of the respective defendants constitutes an invasion of privacy, a trespass, and a conversion of the personal property of USFLC's Assignors and Lion Capital's Assignor.
- 20.4 The Assignors to Lion Capital, The Gas Connection Corp., Rocky Mountain Cleaning & Environmental, Inc., Grayt Enterprises d/b/a Mail boxes, Etc., and Guys & Dolls and the direct Assignors to USFLC have been damaged by the respective defendants' violations of the aforesaid statute.
- 20.5 Respective violations of the statute by each of the defendants is a cause of the damages suffered by USFLC's direct Assignors and Lion Capital's Assignors.
- 20.6 Respective violations of the rights/duties owed by each of the defendants to USFLC's direct Assignors and to Lion's Assignors were a cause of the damages suffered.

B. Knowing or Willful Violations

20.7 The respective defendants have violated the TCPA in a knowing or willful manner. Defendants, for having violated the TCPA in a knowing or willful manner are liable to the Plaintiff for treble damages as provided by statute.

C. Violation of the Colorado Consumer Protection Act

20.8 CRS Section 6-1-702(1)(b)(I), at all times relevant hereto, provides that a person engages in a deceptive trade practice when, in the course of such person's business, vocation or occupation, such person solicits a consumer residing in Colorado by a facsimile transmission without including in the facsimile message, a toll-free telephone number that a recipient of the unsolicited transmission may use to notify the sender not to transmit to the recipient any further unsolicited transmissions. A "toll-free telephone number" as contemplated by the Consumer Protection Act and, as defined in related Federal legislation and/or regulations by the Federal Trade Commission means a number with an exchange of 800, 877, or some similar exchange which is paid for by the sender or fax blaster and, which as a matter of fact leaves a written billing record of the fact of the phone call from the consumer to the subject number. Local area exchanges such as 303 or 720 for consumers in most parts of Colorado, and for Plaintiff's Assignors herein, do not leave such a written record to document or prove if a call has or has not been made.

20.9 Each defendant pleaded above for a "toll-free" violation has either (a) utilized a 303 or 720 exchange for a removal number or (b) has failed to provide any removal number whatsoever.

20.10 Each defendant herein pleaded above who has failed to utilize a proper toll-free removal number has therefore violated the Colorado Consumer Protection Act and engaged in one or more acts of deceptive trade practices.

20.11 USFLC's direct Assignors and Lion Capital's Assignors have been damaged thereby and are entitled to damages as provided by law, including recovery of reasonable attorney fees.

D. Injunctive Relief

20.12 Pursuant to both the TCPA and the Colorado Consumer Protection Act, Plaintiff is entitled to an injunction to enjoin each Defendant from sending future unsolicited fax advertisements and from engaging in deceptive trade practices.

WHEREFORE, Plaintiff, US Fax Law Center, Inc., prays for relief as follows:

1. As to each Defendant:

Judgment for \$500 for each violation of 47 USC 227, *et seq.*, and/or C.R.S.

Section 6-1-701 *et seq.* that was not knowing and willful, coupled with a finding of negligence;

Judgment for \$1,500 for each violation of 47 USC 227, *et seq.*, that was knowing and willful;

Judgment for attorney fees and damages as provided by statute for violations of the Colorado Consumer Protection Act;


2. Injunctive Relief permanently barring each Defendant from further violation of 47 USC § 227, *et seq.*, and prohibiting any future Deceptive Trade Practices under the Colorado Consumer Protection Act;

3. For interest as damages as provided by law, post judgment interest as provided by statute; and,
4. For such further relief as the Court may deem appropriate.
